

Privacy Policy

The official website of the Kochi University Center for Advanced Marine Core Research is governed by the Kochi University Official Website Privacy Policy.

[Kochi University official website privacy policy]

1 Basic Concept

Kochi University (hereinafter referred to as "the University") is a national university corporation. The University collects information on those of you who use its official website (which starts with "http://www.kochi-u.ac.jp/" and is hereinafter referred to as the "Website") to the extent necessary to properly provide services (i.e. provide information on the Website and respond to requests for information and other requests and inquiries) on the Website. The University properly uses the information collected within the scope of the intended purposes.

2 Collection of information

(i) The Website automatically collects your information such as your internet domain name, IP address, and browsing details on the Website.

(ii) The Website collects your personal information you enter in the inquiry form on the Website. This includes your name, address, telephone number, e-mail address, as well as the content of your request. In addition, your e-mail address will be used for communication with the University.

(iii) The Website uses Google Analytics to track its traffic. Google Analytics uses cookies to collect anonymous traffic data. Data is anonymized and there is no possibility that individuals can be identified.

3 Use of information collected

(1) Information collected in 2.(i) is used as a reference to properly provide the services on the Website.

(2) Information collected in 2.(ii) may be notified to the responsible department of the University depending on the content of the request and may be used to contact you.

4 Scope of use and provision

The University will not use or provide to any third party the information collected for any purpose other than those listed in "3. Use of information collected" above,

except (i) in cases where the University has obtained the prior consent of the individual concerned, (ii) in cases of illegal access, threats, or other illegal acts, (iii) in cases where there is a legal request for disclosure, or (iv) in other cases where there is a specific reason. However, the University may disclose statistical information which does not identify individuals (access information, user details, etc.).

5 Measures to ensure safety

(1) The University will take the necessary measures to prevent any leakage, loss, or damage of the information collected, and, to otherwise properly manage the information collected.

(2) When entrusting the handling of the information collected to a third party, the University will take the necessary measures to properly manage the information, such as executing a confidentiality agreement with the party with which the information is entrusted or to which the information is provided.

(3) If you request the University to disclose, correct, or suspend the use of your information collected, the University will respond to your request as soon as reasonably practicable. However, this does not apply in cases where it is believed that it will infringe the rights of a third party or significantly impede the execution of business.

6 Scope of Application of the Privacy Policy

This Privacy Policy applies only to the Website(<http://www.kochi-u.ac.jp/>).

7. Others

(1) This Privacy Policy is subject to revision as necessary.

(2) In addition to the provisions of this Privacy Policy, personal information held by the University is protected in accordance with the provisions of the Regulations for the Appropriate Management of Personal Information held by Kochi University.
